History²

Dandelion is believed to be originally from Western Europe, although today it is spread all over the globe in all latitudes with temperate climates. Over 1000 years before the common era, Arab doctors recognized the medicinal properties of dandelion for treating disorders of the liver, gall bladder, and for treating fever, anemia, and water retention.

Professionals

Dandelion contains numerous active compounds that account for its therapeutic effects, particularly an abundance of bitter active ingredients, terpenoids, flavonoids, and sterols (taraxin and taraxacerin). Other terpenes and sterols include beta-amyrin, taraxasterol, and taraxerol, as well as free sterols (sitosterin, stigmasterin, and phytosterin) whose structure is related to the structure of bile.3 It has been shown that taking Taraxacum officinale orally induces an increase in the secretion of bile.4 Dandelion is a medicinal herb that is considered very well tolerated and safe, with few secondary effects reported in the literature.

Taraxacum officinale is today included in many official pharmacopeias, such as those of India, Austria, Germany, and Great Britain. The German Commission E has recognized its use, particularly for improving biliary functions. ESCOP has approved the use of dandelion root for stimulating biliary and hepatic functions, and Health Canada has recognized its traditional usage as a cholagogue and choleretic.
